Boris Johnson was educated at Eton and Oxford, where he read Classics. He was Assistant Editor of The Daily Telegraph from 1994 to 1999 and then editor of The Spectator until 2005. During his period as an MP, he became one of the most conspicuous politicians in the country, authoring books and making regular television appearances. He served on the opposition front bench, first as Shadow Minister for Culture, Communications and Creative Industries and then for Higher Education.

The Mayor is the elected head of London's strategic authority which exists to promote economic, social and environmental development and wealth creation. Among his direct responsibilities are the policing, travel, support and environmental facilities. The Mayor also has various other duties in relation to culture and tourism, including responsibility for Trafalgar Square and Parliament Square.

Mr Tsang is the current President of the Legislative Council of HKSAR and a member of National Committee of the Chinese People's Political Consultative Conference. He was the Founding Chairman of the Democratic Alliance for the Betterment and Progress of Hong Kong (DAB).

Mr Tsang was educated at St. Paul's College and graduated from the University of Hong Kong. After a period of teaching, he became a full time

politician in 1998.

Mr Tsang's involvement in politics began in 1976, when he was appointed a member of the Guangdong provincial committee of the Chinese People's Political Consultative Conference. He became a member of the Conference's national committee in 1993. Mr Tsang took an active part in the consultative activities when the Hong Kong Basic Law was drafted in the late 1980s and was subsequently appointed to the committee responsible for the preparatory work for the establishment of the Special Administrative Region.

Mr Tsang has been a member in a number of government committees, statutory bodies and education institutes, including the Commission on Strategic Development of the Central Policy Unit, Securities and Futures Commission, Airport Authority, and The Open University of Hong Kong. He is in London for inter-parliamentary liaison and exchange.
